Frank had given much to not only the organization of SPA but its' yearly functions for many years for which we are most grateful. They have a distribution list set aside for them by Webmaster Ed, allowing them to visit with each other via computer like they were all seated in the same room.

Dick Cline SPA # 161 proposed to the Board that rules be amended that would allow models flown up to 25 years of the current year be allowed to legally compete. Our Board is eyeing Clines proposal with perhaps an inclusion of models in 5 year increments up to 25 years prior to the current

year. No action was taken pending more study of the models which might become available for inclusion plus some specific information relating to "pre-turnaround" time periods.

It seems that the question of "allowing retracts" comes as regularly before our Board as does the daily showerbath. It was interesting to note that this particular suggestion has almost always come from outside the boundaries of SPA membership. Your Board has again decided to recognize suggested rules proposals from within our SPA membership. From the Treasurer



Another successful election has passed. Two years ago, Frank Stewart sent stamped addressed return envelopes with the December newsletter/ballot. Response was very high. We did this again this past year, and expanded the effort by sending a newsletter to anyone who had ever had an SPA number, whether they had paid dues recently or not. We sent out

110 stamped return envelopes. To date, we have received dues from 80 of these members. Even as late as mid-February, I still get several renewals each week.

We also sent 106 newsletters to inactive members. Bruce and I felt it might be good just to let them know SPA was still active. Cost on this mailing was about \$100. We have received 12 renewals as a result, bringing \$240 in the Treasury. Several of these members requested additional information for friends, so we may net as many as 20 members we didn't have last year. We'll repeat this excise, also, at the end of this year. It's a good thing to let old friends know you remember them.

The contest schedule is beginning to develop. Cullman, April 27-28, Hotlanta, July 27-28 and the Masters at the Paulding County field September 14-15 are confirmed. We also have proposed contests at Huntsville, AL, Chattanooga, TN, and Bowling Green, KY awaiting final club approval. With Montgomery returning to its usual August date and a return to Cave Springs, we could have nine contests this year. Get ready to travel! It's important to support every club that stages a contest. Jeff Hannah told us in the January Board Meeting that the Chattanooga club has a new site being prepared, but was just a little short of total fund-

ing. We know an SPA contest will help, if we all attend. Bowling Green is an expansion out of our normal area of operation, but is only about an hour north of Nashville. That's about the same distance as traveling to Knoxville. SPA leadership will participate heavily in contest operations to help this club have a smooth first contest. Cave Springs will be running there own contest this year and needs good attendance to encourage them to continue. Huntsville is also new, and has a great flying site. The bottom line is we have the membership to make each of these contests a success. We only need to commit to some travel with friends to support each club offering us the chance to fly.

From The Vice President Hello SPA'ers.

Well here it is. The year 2002 is upon us and it is time to make good on all the rash resolutions made at the



end of 2001. My resolution was to find time and energy to practice the SPA pattern.

If you have a pattern airplane that just doesn't seem to track properly, you might take a look at sealing ALL the control surfaces. This is frequently done with a strip of MonoKote or a clear plastic tape. These work ok but are not a permanent so-

lution to the problem. They eventually succumb to fuel and age. For a permanent seal try this:

Get yourself a tube of GE RTV. RTV is a thin silicone rubber kinda stuff and cures to a very flexible and clear film. Make an application tool out of a 2" long piece of aluminum tubing that will fit snugly over the spout on the RTV tube . Squeeze one end closed with a pair of pliers. Soften the edges of the flattened tube with sandpaper and open the squeezed end a bit, only about 1/64", with an X-Acto knife blade. The tool can now be slipped over the tube spout and you are ready to start sealing.

To seal the surface gaps, deflect each surface UP and apply a thin bead of RTV into the hinge line from the

bottom. When you think you have a nice continuous bead applied, hold the thing up to a light and make sure there are no voids. If all is well, just let the RTV cure for 24 hours with the surfaces in the neutral position. After the 24 hour cure cycle, flex the surfaces full up and down a few tines to break the seal in, and you are done.

It is surprising how many weird little trim problems can be eliminated by sealing all the surfaces. This includes the rudder, too.

If you use CA to install hinges, as I do, you might combine the hinge installation and sealing into one opera-

tion.

The big problem with using CA to install hinges is that the tiny drop you apply to the hinge really loves to run the full length of the hinge line, effectively gluing the surfaces together. If you tape the surfaces in place and apply the TV BETWEEN the hinges, you can then apply the CA and the RTV will prevent the CA from running down the hinge line.

If you feel the need to tool the RTV, you can do so with a paper towel moistened with a bit of lighter fluid, naphtha or other petroleum based distillates.

I am looking forward to seeing every one of you at the contests this year. We will find out how seriously I took my new years resolution.


